# Conditions for Participation for the Experience the World of VEGAN Product presentation

---

## 1. Conditions for participation at BIOFACH 2024

The general conditions for participation in trade fairs and exhibitions apply, including the information on data protection, the special conditions for participation in BIOFACH 2024, the criteria for admission, and the data protection policy of NürnbergMesse GmbH.

## 2. Criteria for participation

Participation is restricted solely to exhibitors registered for and admitted to BIOFACH 2024, who are the manufacturer or exclusive seller of the registered product. All products displayed must comply with the admission criteria and be admitted to BIOFACH.

Registered products must be vegan. The product presentation focuses on alternatives for the vegan diet.

## 3. Application and entry fee

The stand space for a single product costs **EUR 145**. Please send an application form for each product. There is no limit to the number of vegan products that can be entered by each exhibitor. A space of approximately 40 × 40 × 40 cm (W/H/D) is provided for presentation of the product. Only one product may be displayed in this space.

If the number of applications received exceeds the number of spaces available, the products will be selected according to the date of receipt of applications. Deadline for registration is **1 December 2023**. Should the spaces available have already been allocated before this closing date, we reserve the right to an earlier closing date than the one stated. The same applies to the reverse case.

## 4. Presentation

All products are displayed on the special area Experience the World of VEGAN. The display space is allocated exclusively by the company appointed for stand decoration. Your product is presented with a display card, which is designed by NürnbergMesse GmbH and printed with the details taken from your application to the Experience the World of VEGAN Product presentation. We reserve the right to adjust the category selected by you, if necessary.

When you register for the Product presentation, you will receive an additional product profile on the digital event platform. Here you can include a photo, video, document and product description. The products are presented as a separate subpage on the company profile. Products can be found using the product search.

## 5. Number of product samples to be submitted

Please send us at least **5 samples** of each product registered.

## 6. Quantity of product to be submitted

Products meant for presentation must be received by our **forwarding agent Schenker** not later than **2 February 2024**. A **personal delivery** of the products is possible on **12 February 2024 from 8:00 to 18:00 o'clock** directly at the special area Experience the World of VEGAN.

**IMPORTANT:** A smooth delivery can only be guaranteed if you use the **dispatch label template** provided by us. We will send it to you via e-mail together with the confirmation of participation.

Later deliveries, deliveries lost in the post or deliveries with no reference to the purpose of use have no right to a display space. The registration fee cannot be refunded.

## 7. Collection of products displayed

The products displayed can be collected from the special area Experience the World of VEGAN **between 17:00 and 18:00 o'clock on Friday, 16 February 2024**. Please note that in order to collect your products, you need to provide proof that you are authorised to do so (exhibitor badge, business card, etc.). Products that are not collected within this period will be donated to social institutions. The products will be collected immediately after by the respective institutions. Please note that all products that have not been collected by then cannot be returned.

## 8. Cancellation of participation

Cancellation of the participation must be made in writing by e-mail to [eventteam@bifoach.de](mailto:eventteam@bifoach.de). In case of cancelling before the due date, costs will not be invoiced. The exhibitor is obliged to pay the full price of participation fee if the order is cancelled after the deadline **1 December 2023**.
