
Conditions for the participation at Experience the World of OLIVE OIL

1. Conditions for participation at BIOFACH 2024

The general conditions for participation in trade fairs and exhibitions apply, including the information on data protection, the special conditions for participation in BIOFACH 2024, the admission criteria, and the Data Protection Statement of NürnbergMesse GmbH.

2. Admission criteria

Participation at Experience the World of OLIVE OIL is restricted solely to exhibitors registered for and admitted to BIOFACH 2024. Only olive oils are permitted. The oils must be available on the market and originate from certified organic agriculture. Proof is to be sent in advance together with the application.

3. Application and entry fee

The entry fee is **EUR 145** per olive oil entered. Please send an application form for each product. There is no limit to the number of oils that can be registered by each exhibitor.

If the number of applications received exceeds the number of spaces available, the products will be selected according to the date of receipt of applications.

Deadline for registration is **1 December 2023**. Should the spaces available have already been allocated before this closing date, we reserve the right to an earlier closing date than the one stated. The same applies to the reverse case.

4. Presentation

All new products are displayed on the special area Experience the world of OLIVE OIL. The display space is allocated exclusively by the company appointed for stand decoration.

Your product is presented with a display card, which is arranged by NürnbergMesse GmbH and printed with the details taken from your online application for Experience the World of OLIVE OIL.

When you register for the special show Experience the World of OLIVE OIL, you will receive an additional product profile on the digital event platform. Here you can include a photo, video, document and product description. The products are presented as a separate subpage on the company profile. Products can be found using the product search.

5. Number of product samples to be submitted

Please send us at least **8 bottles per 500 ml or 4 liters** of each product registered.

6. Product delivery

Personal delivery of the required 8 bottles to the special area Experience the World of OLIVE OIL between **10:00 and 17:00 o'clock on 12 February 2024**.

Otherwise 8 bottles must be received by our **forwarding agent Schenker** no later than **2 February 2024**.

IMPORTANT: A smooth delivery can only be guaranteed if you use the **dispatch label template** provided by us. You will receive this together with the e-mail confirmation for receipt of application.

Later deliveries, deliveries lost in the post or deliveries with no reference to the purpose of use have no right to a display space. The registration fee cannot be refunded.

7. Participation in the competition of the Olive Oil Award 2024

The award is only presented to producers. Merchants can use it for promotional purposes.

If you take part in Experience the World of Olive Oil, your registered products automatically enter the competition for the Olive Oil Award. Visitors choose their favourite oil from all products displayed.

The presentation of the awards for the winning oils will be held during the exhibition. Certificates are awarded in various categories. Winners and corresponding products may be published on our digital event platform, website or on social media.

8. Cancellation of participation

Cancellation of the participation must be made in writing by e-mail to eventteam@biofach.de.

In case of cancelling before the due date, costs will not be invoiced. The exhibitor is obliged to pay the full price of participation fee if the order is cancelled after the deadline **1 December 2023**.
